
105th Annual Meeting Set in Boca Raton

he Triological Society will elect 15 new Fellows at the Annual Meeting, including three who will receive awards for their theses. Dr. Wendell G. Yarbrough will receive the Harris P. Mosher Award for his thesis, "The ARFp16 Gene Locus in Carcinogenesis and Therapy of Head and Neck Squamous Cell Carcinoma." The Edmund P. Fowler Award winner is Richard D. Kopke, MD. His thesis is entitled, "Enhancing Intrinsic Cochlear Stress Defenses to Reduce Noise-Induced Hearing Loss." The Council selected Dr. Christopher Linstrom's paper, "Objective Facial Motion Analysis in Patients with Facial Nerve Dysfunction," for an Honorable Mention for Clinical Research.

Dr. Yarbrough is Associate Professor of Otolaryngology/Head and Neck Surgery at the University of North Carolina at Chapel Hill. He was proposed by Harold T. Pillsbury, MD, and seconded by William W. Shockley, MD. Dr. Kopke is Co-Director of the Department of Defense Spatial Orientation Center at the Naval Medical Center in San Diego. His candidacy was proposed and seconded by Darrell Hunsaker, MD, and J.V.D. Hough, MD, respectively. Dr. Linstrom was proposed by Dr. Steven D. Schaefer and seconded by Paul L. Chodosh, MD. Dr. Linstrom is Associate Professor of Otolaryngology/Head and Neck Surgery and Director of Otology and Neurotology at New York Eye & Ear Infirmary, New York City. He is also Associate Professor of Otolaryngology/Head and Neck Surgery at the New York Medical College, Vallhalla, N.Y.

SPOTLIGHT

on the Southern Section

Q: The First Place Resident Research Award in the Southern Section this year is named for John E. Bordley, MD. Who was he?

A: John E. Bordley, MD, was President of the Triological Society in 1964. Born Nov. 8, 1902, Dr. Bordley was Professor and Director of Laryngology and Otology at Johns Hopkins Hospital in 1952 and Andelot Professor and Director, Department of Otolaryngology at Johns Hopkins Hospital from 1962-1969. He had a particular interest in hearing and communicative disorders, especially as they related to children, and helped establish the Speech Clinic at Johns Hopkins, the first of its type affiliated with a medical center. He later helped form a similar facility at Boys Town National Research Hospital. A John Bordley Chair in Otolaryngology — Head and Neck Surgery was installed in his honor at Johns Hopkins.

During his presidency, the Council adopted a Code of Ethical Publicity for candidates and members. Members of the Society had to accept the principle that publicity for personal gain would not be condoned. Also during his tenure, the Council corrected an oversight by adding Alaska to the Western Section.

The Southern Section of the Triological named one of its Resident Awards for Dr. Bordley in 1996. He died in 1993.

Proposed Changes to Bylaws on Annual Agenda

BYLAWS REVISIONS

The membership is asked to review the proposed changes and cast a vote at the annual business meeting. Proposed changes appear in large, bold type. The explanation is in bold italics. These revisions were approved by the Council in May, 2001.

Section 5. Duties of Officers.

(a) President. The President shall be the chief executive officer of the Society and shall see that all orders and resolutions of the Council are carried into effect. The President shall preside at the Annual Meeting of the Society and shall arrange for the scientific program of the Annual Meeting in conjunction with the Coordinator for Continuing Medical Education. *This addition will adhere to ACCME standards*.

Section 5. Section Meetings.

(a) Unless otherwise decreed by the Council, there shall be one (1) Section Meeting held by each section each year. Each Section Vice President shall determine the place of the Section Meetings. All Section Meetings shall be held in January or **February** unless otherwise authorized by the Council or the Executive Committee.

This addition is necessary due to changes in dates for Western Section Meetings.

VI. MISCELLANEOUS.

Section 1. Amendment of Bylaws. Proposed amendments to these Bylaws shall be presented (in writing) omit to the Council. (and shall have been signed by two (2) Active, Senior, or Emeritus Members.) omit If approved by the Council, written notice of the proposed amendments will then be sent to all Active, Senior, and Emeritus, Members at least one (1) month prior to the next Annual Meeting. Approval of the amendments will require the affirmative vote of three-fourths (3/4) of those present at the Annual Meeting and entitled to vote.

This allows individual members to approach the Council with suggestions and allows Council members to discuss/propose amendments during regularly scheduled meetings of the Council; often these issues relate to accreditation, grammar and simple "housekeeping" issues.

Section 6. Organizational Provisions. Notwithstanding any provision of these Bylaws to the contrary, until such time as the Society shall have members, the initial board of directors named in the Articles of Incorporation shall constitute the Council, and said Council members need not be members of the Society and shall have the following powers in addition to those otherwise provided in the Bylaws:

- (a) To elect and designate the officers and directors of the society; and
- (b) To amend the Articles of Incorporation and Bylaws by majority vote of Council members present at any regular or special meeting provided that notice of any proposed amendment is provided at least seven (7) days prior to the meeting or to do the same by unanimous written consent.

Council voted to omit entire Section 6 which is no longer applicable – note that this Section states that Council members need not be members of the Society.


Membership Boosted by Candidates, Residents, Postgraduates

embership figures as of January 2002 show the impact that younger otolaryngologists are having on the Triological Society. While the number of Active Fellows has decreased in the last couple of years, the number of Candidates, Residents and Postgraduates is on the rise. The number of Residents and Postgraduates has soared since the Society created those membership categories in 1993. In 1993, the

Society had 42 Residents and 23 Postgraduate members. In January, the figures were 174 and 143, respectively. Also, as of the first of the year, the Society had 113 Candidates in the process of meeting active fellowship requirements.
